## 2007-2008 ONLINE RENEWALS A SUCCESS

Thank you to all of the businesses that renewed online for the 2007-08 year. As of August 1, 2007 86% of the renewals were processed online. For 2006-07 the online renewals were only 34%! ## 45 DAY TEMPORARY PERMITS

As of **November 1, 2007** the price for 45 day temporary permits will increase to \$187.75 per pad of 25 permits. Please use the enclosed new TC-756 order form (rev 9/07), for any orders placed on or after November 1, 2007. Remember you can also order online and pay by credit card.

Please be sure not to issue Motor Vehicle Enforcement Division permits to watercraft. Contact the DMV at 801-297-7780 or 1-800-368-8824 to find out how to obtain watercraft permits. Issuing Motor Vehicle Enforcement Division permits to watercraft could result in fines and penalties for each permit issued. **Do not make this costly mistake by issuing the wrong permits to watercraft!**

## OWNER OR SALESPERSON LICENSES

If an owner (new or used dealer, new or used motorcycle or small trailer license) or a salesperson license is expired or suspended for **6 months or more**, a new fingerprint card, a fingerprint waiver (TC-465) and photo must be submitted with any applications along with the \$15.00 BCI fee to process the background check.
