#### **MVP**—Motor Vehicle Portal

Dealers, there is a new way to have your titles and registration processed! It is now possible for dealers to upload documents through MVP to process titles and or register vehicles. When the title/registration transfer is completed, the plates will be mailed to the customer and an itemized receipt will be emailed to the dealership. \*Note MVP can only be used for title transfers. Title corrections, plate or decal replacements, etc cannot be done through MVP.

#### **MVED MVP— Curbstoner Reporting**

Another name for an unlicensed dealer is a curbstoner. You can report curbstoners on the MVP website <a href="mailto:mvp.tax.utah.gov">mvp.tax.utah.gov</a>. Under the Enforcement (MVED) section from the portals home page you will find the link titled "Report an unlicensed dealer (Curbstoner)"



You will then be prompted to enter your information, however, it is not required. Next you will enter the VIN / HIN of the vehicle and any identifying tags. From the next page you will enter the date and the location you spotted the vehicle up for sale. If the vehicle was spotted on the street we will ask for an address and any nearby landmarks, or if the vehicle was located on the web you can copy and paste the web address. After that you will enter the information for the vehicle's listing; phone number, name, and listed price. Don't forget to hit submit when you're finished!

## Filing a Complaint

If you need to file a complaint about a motor vehicle transaction, please complete Form TC-451, Original Complaint Report and submit it by postal mail to the address on the form, or by email to mved@utah.gov. #### Form TC-466 FAQ

What charges can be included in the "Optional charges" section?

The "Optional charges" section may only include charges for goods or services that the purchaser may decline and still be permitted to purchase the vehicle for the negotiated price. If the negotiated sale price includes certain goods or services, then the charges for those goods or services are not considered optional.

If there are more than 6 optional charges, can an addendum be used?

Yes, an addendum to form TC-466 may be used. If an addendum is used, the total from the addendum must be listed within lines a-f of the "optional charges" section of form TC-466. Additionally, if an addendum is used, the "total optional charges" on line 4 must include the total of amounts listed on any addendum.

What type of vehicle sales require a completed TC-466?

The sale by a dealer of any new or used motor vehicle as defined in Section 41-3-102 must be accompanied by a completed form TC-466.

#### Sales Tax on Out of State Purchases

Please do not assist customers in avoiding the payment of lawful sales tax on any vehicle purchase. All dealers must maintain complete and accurate records for any sale in which Utah sales tax is not collected.

#### MVED 45-Day Temporary Permits CANNOT be issued to watercraft

## **MVED Temporary Permit Fees Changed 01/01/2023**

Passenger/Lt Truck Vehicles	\$58.00
Passenger/Lt Truck Vehicles with expired permit	\$116.00

Vehicles weighing in excess of 12,000 lbs gross weight are charged a 1/4 year registration fee. Please call MVED at 801-297- 2600 for the amount. The weight of the vehicle must be listed on the temporary permit. If the permit has expired a 100% penalty will also be assessed.

Motorcycles Motorcycles with expired permit	\$58.25 \$116.50
Off Highway Off Highway with expired permit	\$41.50 \$83.00
Snowmobile Snowmobile with expired permit	\$28.50 \$57.00
Trailer Trailer with expired permit	\$36.75 \$73.50
