### **Renewal Reminder**

All MVED licenses expire June 30th each year. Be sure to renew in a timely manner so we have time to process your renewal and get decals (if applicable) mailed out to you.

### **MVED Licenses are now online in your Businesses MVP account**

Your MVED licenses will now be online. You can now log into your MVP account and print those licenses anytime. When we process a transaction for a license you will get an email reminding you to log in and print. You can also print out replacement licenses if they are lost.

### **Price of 45 day temporary permits is increasing 7/1/2024**

The price of the 45 day temporary permits is increasing on 7/1/2024 to be \$331 per pad of 25 permits.

### **TC-466**

Please do not send a copy of the TC-466 in with your title/registration documents to the DMV. That form should be kept in the dealer jacket.

### **MVED Complaint Forms will have another option on how to file**

MVED Complaint Form will have an option to submit completely electronically on/after July 15th. There will be a link to the complaint report via the MVP portal.

You will still be able to download and complete the paper form as well.

## **MVED Temporary Permit Fees Changed 01/01/2024**

Passenger/Lt Truck Vehicles	\$68.25
Passenger/Lt Truck Vehicles with expired permit	\$136.50

Vehicles weighing in excess of 12,000 lbs gross weight are charged a 1/4 year registration fee. Please call MVED at 801-297- 2600 for the amount. The weight of the vehicle must be listed on the temporary permit. If the permit has expired a 100% penalty will also be assessed.

Motorcycles	\$68.75
Motorcycles with expired permit	\$137.50

Off Highway	\$41.50
Off Highway with expired permit	\$83.00

Snowmobile	\$28.50
Snowmobile with expired permit	\$57.00

Trailer	\$46.25
